Not to mention the fact that people were FAR too willing to accept shoddy workmanship that resulted in shipping damage as something inevitable when shipping a pack. That to me is letting him off the hook. The photos showed vulerable parts held on with a couple dabs of glue, which is bad workmanship. Also if I paid for a car and it was being delivered and it showed up with a busted window, no way in hell I would accept from the seller or anyone else that it's my job to repair it.

He's talked a big game and doesn't live up to what he makes himself out to be. There are a lot of people (as Sean mentioned) who are VERY unhappy with his stuff. I think there are a lot of people that may not know any better as to the quality or accuracy of the parts or props they are getting.

Rhett says we never message him?

I've chatted with alot of people, and they've posted here also, that they message him and message him and NO RESPONSE. As Sean said, the only other discourse is go to AJ or himself. There were times I messaged him and nothing, especially about shipping.

I admit I was personally late with my payment but that's because I actually, in REALITY, had a finanical problem, that i'm actually still having, which is a whole other story, so I just could not pay him. Anyways...for you guys to know what the private messages are like between a "customer" and the Vendor himself, here is a PM I sent him regarding my sadness at first view of his "kit" and his fairly immediate response. I'll leave it to you guys to decide the tone of both PMs.

MY PM:

Hey,

I received your gun kit today and I have to admit i'm a bit dissapointed.

In no way am I trying to be "mean" or "offensive", but I have to let you know that your pictures you posted were very misleading, as I didn't realize the castings would be this...low in quality. I understand completely that it's a "kit", but for the price paid I do believe a "kit" would still be something you could just "put" together" with a little bit of cleaning and finishing. Some of these pieces will take me longer to just clean up than it would for me to scratch build the pieces myself.

Your pictures had the gun body and trigger box cut from the rest of the vac-formed plastic, whereas my kit they're still attached.

The grips look cleaned in your picture, which confuses me to as to why the castings of the grips I received were almost deformed.

I honestly appreciate your efforts to help some propers out, but especially beginning propers, this kit would be very, very difficult to clean up and finish.

Also, I sifted through the box and found that there are some missing parts:

- 1.) The bigger knob on the right side of the gun next to the slo-blo box
- 2.) The banjos are missing

This is just at first glance.

Well, i'll leave it at that for now. Judging from the amount of time it'll take me to put this together with my cousin before Halloween, I just don't have time to put it together well. So I ask if I can return it with a full refund.

Again, I appreciate your efforts in helping propers out, but I expected, from visual advertisement and most importantly, cost.

I don't assume your personal thoughts and feelings into your "business" you've created as a vendor of parts and services, but from what I see, there seems to be no pride in your work.

I write this as my experience and opinion, and don't mean to attack you at all. Thanks again for everything man.

-ThiagoHIS RESPONSE:

Sorry you feel that way. But you've received what everyone else has received, and they've not only been able to work with the kit, but some have raved about it. These comments I've received from you are not typical of others, and while I'm sorry for how you feel, you are alone in your feeling. The castings are not "rough." they are fairly clean, and ready to sand and paint. The pics are of the part masters and the exact thing

you've received. Vac formed parts are never sent precut. I can't be expected to precut 120 peices. It was never infered that it was precut.

Clearly, you are inexpereinced and uninformed. But, so was I once. You've recevied a good kit, and I'll be following up with those missing pieces. As for receiveing it today. .I doubt that since it was shipped priority, so it should have been there last week for you to build with plenty of time.

As for the comment of having no pride, that's highly offensive and it is an attack. I have agreat deal of pride, and am he only part supplier whose gone the extra mile in provideing exact and accurate parts. We are not Revell or MR, and our parts may not be C&C'ed, but the should at least reflect the scratch built nature of the props. I should remind you that I waitied a long time for your cash, and held a kit for you, adn you were genrally a pain in the ass. You also should know by know, if you've been paying attention, that 120.00 for a gun is a small price to pay. I think you should take another look at the kit, get the downloadable instructions here tommorow, get you dremel and get to work. You'll be surpised how fast it goes together. If I can build four of them in a day, you can build one in three days.

I'll get the new pars in the mail, if I can calm down form your PM Thanks

AGAIN, I do this only for you guys to see for yourself.

At this, i'll leave it alone, as I feel this is the part I needed to play.

Those castings are hard to defend.

Not fer nuthin' Rhet but what are you using for resin? Are you putting a dye in that? Cause if you're not, it looks a whole Hell of a lot like 1630 and if it is, that's way too thick to pour into a mold, dude.

It's a thick brush-up resin for capturing surface detail in fiberglass layups.

You need to switch to pour-a-kast or some other two part white stuff. It's strong when it dries, sets up quick, and is easy to work with in it's final form.

I've worked with 1630 enough to know what it looks like and that's indeed, what it looks like.

It also looks like you're combining resins in some of the pieces. Mixing the last of a black colored batch with a new white one which doesn't necessarily bode well for even set-up, nor does improperly mixing a resin dye in with a white resin.

If the dye is mixed incorrectly you can get delaminating.

No offense,.....but 99% of offering a good kit is engineering good bucks for the proper molding techniques to minimize undercts and bubbles and mold wear and tear.

It took me months to properly do the bucks for my particle thrower kit and when I was done I got this.





And which assembled cleanly into this,....





And NO I'm not posting these photos to rub your nose in it. It's simply to show that it CAN be done.

But the kits took me time. I offered them in like,....March of whatever year I did the run, I only did ten kits and there was a lot of prep, (as well as some cleanup work), involved. they took me forever and some people waited until early October but everybody got their stuff, no one complained and everyone I talked to said it was well worth the wait.

Quality, in my experienc, beats out quantity every time.

However, in the past week, I have seen, first hand, the work, time, effort, and yes pride, that went into getting these kits ready.

I know that people have had problems in the past with items cracking or breaking during transit, but those were full build ups, and those mistakes were learned from and shipping practices changed. To bring those complaints, which were already handled and taken care of, into these current issue is ridiculous.

Of the pics that were posted, it looks like all that needs to be done is to take out the exacto knife or dremel, cut some flash, and sand. There is no "needing to rebuild from scratch" necessary. If there were, I wouldn't be in the middle (or couldn?t based on some of these post) of building my pack/gun kit. Nothing that shipped in those kits is beyond some simple supplies from the hobby shop.

As far as the "i would never send this out" quality comments, why would you think that no work would need to be involved in this kit. To pay less then \$500 for a FULL proton pack kit and expect fully cut and sanded vaccu-formed parts? are you serious? As one of Rhett's partners, I have to should some of the burden here as well. I put most of this on Rhett's shoulders to do and lets face it it was too much for one guy. I should have stpped up myself, helped cast pieces, cleaned up casted pieces and inspected what was going out before it was shipped.

That being said, what to do? One way or another AW Studios will try to make amends for the poorly casted items. Here is what I propose:

We will be getting new molds poured from the masters. We have casting materials (no Sean it is not 1630) on the way. We will offer replacement pieces to our customers. We cannot replace entire kits, but replace the poorly cast pieces. We ask that you to send me the name of the piece and a photo of it for our records. Once the new master molds are done, we will cast new pieces, make sure the flash is cleaned up and prime them for you. Unfortnately being a Garage Kit shop, we are not in a financial situation to be able to offer refunds. Revenue generated has gone to pay for material expenses and work space expenses.

We will do our best to turn this fugly situation around.

On a side note, as mentioned in another thread, please do not implicate Strangestuff Studios with Aw Studios. The owners of Strangestuff our people of hi caliber and offer some of the best model and prop build-up services around. Their quality of work is impecable. They are in no way resoinsible for the poor quality of some of our kits.

Also, until we do get our act together, we will not be putting up any preorder sales and so-on. And if we do ever offer anything else, we will make sure the kits are already done and will take hi-res photos for you to see ahead of time.

Please e-mail the name of the part a a photo and I will start making a list of what needs to be replaced. This will have high priority. Please e-mail to awstudios@verizon.net

Finally, as Rhett has mentioned, we (and he) do not need anymore personal attacks. Mistakes were made and we will endeavor to correct them. Rhett truly does love this community and he truly does want to give back by offering good parts. We are all human and make mistakes.



After reading over this all day and thinking on whether or not I should weigh in on this, I have finally decided that I should. I bought a gun kit from Hotshot, and when it arrived I was let down to the extent that more work by myself would need to be put into this thing then I had orginally thought would be needed. I also felt that the pictures that were posted of the kit, were infact different than what was sent to me. However I did not contact Hotshot with my feelings as I didn't want to stir any problems, I knew he was busy with many other orders and I thought that perhaps my kit was just a fluke. So I figured I would take it, and do my best to clean it up, sand it, bondo, paint it, etc. I compared the progress of how it was coming along to the gun I was planning on replacing with this kit and said to myself "why would I replace the gun I already have with this?". So I took the acrylic tube and added it to the gun I already had (all it was missing was the acrylic tube) and called it done. There were some detail parts that I did like from his kit after cleaned up as best as could be, and I still plan on finishing his gun kit over a period of time, so I can have a back up. Some of the things I was dissapointed in was the PVC tubes being oddly cut (I had to re-cut them myself), the knobs that came with it were not of great quality (I had an extra set of knobs from someone else I'm using instead), the acrylic tube was oddly beveled (but if you look at it a certain way, it gives a cool look anyway as if being used alot and sort of melted), the banjo's are completely shot with huge air holes especially in the one (again I had spare banjo's from the newer castings of someone else that I used instead), the trigger box and gun body had to be trimmed, and the grips needed a ton of sanding, cutting, sanding, bondoing, sanding again, and they still feel wierd. And some pieces were missing from the kit such as the vhook that was later added to the kit and was supposed to go out with these, and the belt hook disk and hook.

What I did like about some of the parts was the nice casting of the Clippard, the bar on the bottom part of the gun that has the green hose and red light on it, the heatsink was also alright, palm rest is good, the ring and "gun trigger" that go around the acrylic tube, after some work on the gun track it turned out fairly decent (it's not as warped as like in the picture on the previous page). Also the decals were awsome I like them alot.

Now if I saw the pictures of how this kit was actually going to arrive to me I would not have spent the \$130 to get it. Simply put that is my opinion whether you want to agree with it or not. I'm also not asking for AW Studios to send me anything to replace what is missing or parts that can't be used, if I was expecting that I would have PM'ed Rhett.

I believe what has people upset for the most part is the advertising of what was to be sent. Now if pictures were posted of the castings and not of the masters of which these were going to be casted from, there probably would not have been a problem. Here is what was posted at "The Topia":

Alot of work went into this, and the materials are of the highest quality. Kits will be made to order, and will take, at most, two weeks to process an order, from your purchase date.

Now that get's into the turnaround time to actually get something. He said it would take two weeks at most, and it took about a month:

- 2.Mike_D PAID 8/18 SHIPS 9/14
- 3.Addlema PAID 8/15 SHIPPED 9/13

It was supposed to be shipped numerous times but was delayed multiple times. I think it could be perhaps because Rhett bit off more than he could chew. He wanted to help everyone out so he kept taking orders, from goggles, to packs, to guns, to traps. I think he means well. I would suggest though that in the future you have a certain amount of kits already made, all set to go, and don't take so many orders especially promising to have them filled by 2 weeks.

By no means at all am I trying to make trouble for Rhett or his propping business, but you also need to understand that if you can't take critisism from feedback regarding what you are selling to people, you should not continue making stuff. Now on the otherhand people talking about going on a witch hunt to seek you out in Baltimore is completely inapropriate and not cool.

Rhett I want to continue to see you build stuff, and be able to offer them to us all, perhaps in a different way, such as showing us what the actuall castings look like and not the masters, and to not take so many orders at once as one man (or two) can only do so much. Don't lose sleep over it. I also look foward to getting the trap kit from you as well. The mailman had it with him today but I wasn't home to sign for it, so I'll need to wait until tomorow to pick it up 3 4.

Well, I had dealings with Rhett Martin, aka: HotShotDraw. It wasn't a totally pleasing experience.

Here's the deal: I hired him to build a proton gun and ghost trap. The total was \$480. I paid him a \$200 downpayment. Too, I ordered the props several months prior to Halloween.

About August, I bought a Hyperdyne light kit for him to install for me. I offered to pay, he rebutted that he could use the experience and wouldn't charge me. Cool.

Late September, I was getting antsy, emailed him, asked when to expect the items, he promised, 2 weeks. I replied that was good as I had parties to go to the 2 weekends before Halloween.

2nd week of Oct. and still no props. He promised they had been sent, but kept "ignoring" my requests for a tracking number. Nothing. Finally, with a week to go, he says he had been waiting for a "green tube" so that I could have an "accurate" prop. Whatever, just send my props, please.

Finally, the Friday before Halloween, after he promised he had sent the items overnite via USPS (for those of you who know, USPS DOESN'T OFFER overnite delivery), I called the local USPS to find the package, luckily, was at their station, set for Sat delivery. I went ahead and picked it up.

Rhett packed the items in a cramped, at best box. And, instead of bubblewrap and/or peanuts, he wadded up newspaper and stuffed them into the box. This may have well been packed in wood blocks. The items, needless to say, were destroyed in transit. Absolutely useless.

SO, I email him. I was pissed, and told him so. He could have cared less. Basically, "I have your money, tough crap." He didn't even insure the items (except for the standard USPS \$100 insurance ... which wouldn't even cover the loss of my \$165 Hyperdyne light kit!) And, BTW, he mounted that wrong, and with the wrong front light set....

He finally offered to fix them at my expense and on his time schedule. And, he promised that USPS was sending me a check as he had filed the measly \$100 claim. The check NEVER arrived. And, he quit returning emails. So, I refused the charges on my credit card. Now, he's claiming not to have the items back, and is appealing the reimbursement. Yet, I can't send them back because he refuses to email me his address. Basically, he is forcing the reversal of the refund and is forcing me

to accept the delivery of broken props which he refuses to fix. He could, at least, send a partial refund ... if he were a reputable and trustworthy businessman.

As for the parts, shoddy and poorly crafted at best. Parts of the ghosttrap were incorrectly cut, the wheels didn't roll, the pedal was garbage BEFORE it was broken, the gun body looked too flimsy to even carry (as the only things holding it together were the wires from the hyperdyne kit after it was broken), and the barrel lights were wrong and dim.

At first, before he had my full payment, Rhett was pleasant to deal with. But, when the chips were down, he took my money and stuck me with useless, broken garbage. I wouldn't recommend ANYONE buy from this crook. (BTW, I've had dealings with Jeremy Moore, some good, some bad, but, in the end, he's ALWAYS done the right thing.)

Unfortunately, this has been difficult, as we have yet to come to an agreement on splitting the assets and making sure all customers products have been shipped.. Rhett physically has all of the Ghostbuster parts, molds, etc. Since they are in his possession, I do not have access to them. He is also known as AW Hotshot on Proptopia.com and Hotshot on GBProps.com. I believe Rhett will be continuing to sell GB props on his own (he recently had an auction up for a GB Stunt Trap under his Hotshot or Hotshotdraw eBay account).. Since he currently has the missing parts you did not recieve in your kit, he would be the best person to contact.

I apologize for not alerting you sooner, but this situation with him has been very trying and draining on me. I will try to communicate to him again about sending your parts, but I am not sure if it will do me any good. You best bet may be to contact him directly.

Here I was thinking it was about time I posted my warning about Rhett Martin that I find he's at the top of the list! I'd love to take the opportunity to vent my frustrations over this individual.

I can't say that I'm very skilled with my hands, so I figured I'd take the fear out of making my first proton pack by getting a kit. I saved up my money and bought a gun / pack kit from Rhett off of e-bay. Needless to say, it went quickly sour.

To be brief, what should have been a great experience was wrecked by Rhett's lack of workmanship, unprofessional ism and deceit.

I received my items shipped rather like others, with little care in packaging whatsoever, and they

were all damaged beyond my ability to repair. it took FOUR MONTHS of back-and-forth e-mails to get me "some" items shipped. I found the quality of the parts themselves rather poor and simplistic. I can't tell you how frustrating it was to communicate with him, since every e-mail was vague and full of false promises.

If I look at the mistake I made, is that I was trusting. When the items showed up damaged, I put in a complaint with e-bay / paypall. Rhett managed to convince me he'd fix the problem, and not having the money would severly interfere with his life. I took his word and retracted the complaint. Soon I found myself stuck with the faulty pack, as he went beyond the 60 day time limit you have to launch a complaint. I was soon at the point where I would have to deal with VISA and their credit goons to get what I wanted.

When the part finally showed up, it wasn't what we discussed, nor what he promised. It'll take more time to repair the pack and gun than I think it would be to scratch-build!












Poorly cut PVC pipes for the handles














I liken the view of these grips to that of something in a very, very strange dream...you wake up thinking, MAN that was just weird looking!

AND NOW on to something else..

Rhett says we never message him?

I've chatted with alot of people, and they've posted here also, that they message him and message him and NO RESPONSE. As Sean said, the only other discourse is go to AJ or himself. There were times I messaged him and nothing, especially about shipping.

I admit I was personally late with my payment but that's because I actually, in REALITY, had a finanical problem, that i'm actually still having, which is a whole other story, so I just could not pay him. Anyways...for you guys to know what the private messages are like between a "customer" and the Vendor himself, here is a PM I sent him regarding my sadness at first view of his "kit" and his fairly immediate response. I'll leave it to you guys to decide the tone of both PMs.

MY PM:

Hey,

I received your gun kit today and I have to admit i'm a bit dissapointed.

In no way am I trying to be "mean" or "offensive", but I have to let you know that your pictures you posted were very misleading, as I didn't realize the castings would be this...low in quality. I understand completely that it's a "kit", but for the price paid I do believe a "kit" would still be something you could just "put" together" with a little bit of cleaning and finishing. Some of these pieces will take me longer to just clean up than it would for me to scratch build the pieces myself.

Your pictures had the gun body and trigger box cut from the rest of the vac-formed plastic, whereas my kit they're still attached.

The grips look cleaned in your picture, which confuses me to as to why the castings of the grips I received were almost deformed.

I honestly appreciate your efforts to help some propers out, but especially beginning propers, this kit would be very, very difficult to clean up and finish.

Also, I sifted through the box and found that there are some missing parts:

- 1.) The bigger knob on the right side of the gun next to the slo-blo box
- 2.) The banjos are missing

This is just at first glance.

Well, i'll leave it at that for now. Judging from the amount of time it'll take me to put this together with my cousin before Halloween, I just don't have time to put it together well. So I ask if I can return it with a full refund.

Again, I appreciate your efforts in helping propers out, but I expected, from visual advertisement and most importantly, cost.

I don't assume your personal thoughts and feelings into your "business" you've created as a vendor of parts and services, but from what I see, there seems to be no pride in your work.

I write this as my experience and opinion, and don't mean to attack you at all. Thanks again for everything man.

HIS RESPONSE:

Sorry you feel that way. But you've received what everyone else has received, and they've not only been able to work with the kit, but some have raved about it. These comments I've received from you are not typical of others, and while I'm sorry for how you feel, you are alone in your feeling. The castings are not "rough." they are fairly clean, and ready to sand and paint. The pics are of the part masters and the exact thing you've received. Vac formed parts are never sent precut. I can't be expected to precut 120 peices. It was never infered that it was precut.

Clearly, you are inexpereinced and uninformed. But, so was I once. You've recevied a good kit, and I'll be following up with those missing pieces. As for receiveing it today . .I doubt that since it was shipped priority, so it should have been there last week for you to build with plenty of time.

As for the comment of having no pride, that's highly offensive and it is an attack. I have agreat deal of pride, and am he only part supplier whose gone the extra mile in provideing exact and accurate parts. We are not Revell or MR, and our parts may not be C&C'ed, but the should at least reflect the scratch built nature of the props. I should remind you that I waitied a long time for your cash, and held a kit for you, adn you were genrally a pain in the ass. You also should know by know, if you've been paying attention, that 120.00 for a gun is a small price to pay. I think you should take another look at the kit, get the downloadable instructions here tommorow, get you dremel and get to work. You'll be surpised how fast it goes together. If i can build four of them in a day, you can build one in three days.


These are pictures of only a few parts that were recast by Rhett Martin. There is also a set of foam grips that Rhett recasted. Those were brittle and fell apart with-in days of getting them. I purchased a set to see the quality myself and it was quickly found that they were recasted.

The photos here are a set of knobs that were made by a user called Phantom50 (Brock). The first sets are HIS masters. The 2nd set of photos are the recasts from Rhett Martin. Also seen are some horrible casts he did. Those who got the parts (and knew what they were looking at) described them as not having enough time to cool down or set.

These photos are of the masters and casts **from Phantom50** that were subsequently recasted by Rhett Martin. Rhett claimed that he thought all the items were "found" and therefore could be used and recasted freely.

I hope this was enough information to take action against Rhett Martin.

The RPF surely does not want to kind of trouble that he causes when offering his parts. He disappeared for about a year and stopped making Ghostbusters stuff.. but now he is back and seems to be making those things again. They are hugely expensive and his quality of work is HORRIBLE. Enough parts that he offered were recasted from better 'reputable' members of the Ghostbusters and Prop Making communities. He has recently been getting involved in professional promotions with Sony Pictures but was QUICKLY removed as soon as they realized what he has done in the past.

Also know that Rhett Martin is banned AND blacklisted on every major Ghostbusters Website / Forum. It is made sure that most users know what he did and why not to purchase from him. It wasn't a problem but now he appears to be making things again.

He is Blacklisted and Banned on:

Ghostbusters Fans (http://www.GBFans.com/) – Formerly GBProps.com is my website and he has been banned for several years now.

Ghostbusters.net – A large website dedicated to Ghostbusters.

Proptopia – A small Prop makers site focused on Ghostbusters where he did the majority of his selling.
